REGULATION
on holding
International mas-wrestling tournament
«Kolmar Cup - 2023»

Vladivostok – Russkiy Island, Russia

I. Aims and objectives

The aim of competition is popularization of mas-wrestling in the world.

Objectives:

- strengthening friendly relationship among countries;
- determination the strongest mas-wrestling athletes in the world.

II. Date and venue

International mas-wrestling tournament «Kolmar Cup - 2023» is held in Vladivostok Primorsky Krai, Russia, within sports program VIII Eastern Economic Forum on address: Russkiy Island, Exhibition «Far Eastern Street» on September 9-14, 2023.

Arrival days – September 10–11, departure day – September 14.

III. Management

General management of preparation and holding of competitions is carried out by the International Mas-Wrestling Federation, All-Russian Mas-Wrestling Federation, Ministry of Sport of the Russian Federation, JSC «Kolmar Company», SBI of the Republic of Sakha (Yakutia) «Republican Center of National Sports named after Vasiliy Manchaary», Mas-Wrestling Development Fund «Planet Mas-Wrestling» and Organizing Committee on the preparation and holding Eastern Economic Forum.

Direct responsibility of holding the event carried on the Grand Jury, approved by the International Mas-Wrestling Federation.

IV. Conditions for holding and participants

Allowed to participate in the competition by personal invitation of International Mas-wrestling Federation, permitted to engage in power sport and passed medical examination.

Competitions are of a team nature and are held among men and women according to the current rules of the International Mas-Wrestling Federation with division into groups "A" and "B".

Teams are includes three athletes, which have one athlete in a weight category. Distributing of participants into teams is made by the Grand Jury during the weigh-in procedure. The names of the teams are given by organizers.

Weight categories:

- men – 90 kg and 125 kg;
- women – up to 75 kg.

Meetings between the teams will be held according to the "wall to wall" system, that means, each athlete participate in one bout with an athlete of his weight category from the opposite team. The team that wins the most bouts - wins the meeting.

According to the draw, the teams will be divided into 2 groups (group "A" and group "B") of 4 teams each.

At the first stage, the teams will compete with each other in a round-robin system within each group, where 1 point is given for a win, 0 points for a loss. According to the results of the first stage, places in each group are distributed according to the points scored, in case of equality of points for two or more teams, their places are determined taking into account the following indicators:

- by winning in a mutual meeting (when determining the places of two teams);
- by the quality of all bouts, that is, by the difference between all won and all lost fights at the first stage (the greater the difference, the higher the place in the group);
- by the lower total weight of the teams during the weigh-in (the lower the weight, the higher the place in the group).

At the second stage, the teams will meet according to the following scheme:

For 7-8 places in the tournament – the teams that took fourth place in the groups at the first stage;

For 5-6 places in the tournament – the teams that took third places in the groups at the first stage;

For 3-4 places in the tournament – the teams that took second places in the groups at the first stage;

For 1-2 places in the tournament – the teams that took the first places in the groups at the first stage.

Participants are obliged to compete in sportswear according to the Rules of the International Mas-Wrestling Federation (Mas-Wrestling shorts of red or blue colour (according to drawing) and sports shoes without spikes with soft sole. Parade uniform with logos of the event organizers and the sponsor organization is allowed.

VI. Awarding

Top three team-winners of a tournament to be awarded with medals, diplomas and special prizes.

Award and souvenir products are provided by the organizers of the tournament as agreed.

VII. Financing

All costs connected with the preparation and holding of the competition, under the terms of the equity, carry JSC «Kolmar Company», State Budgetary Institution of the Republic of Sakha (Yakutia) «Republican Center of National Sports named after Vasiliy Manchaary».

For earmarked funding, JSC «Kolmar Company» enters into a sponsorship agreement with the Mas-Wrestling Development Fund «Planet Mas-Wrestling».

VIII. Safety

Competitions to be held in sport buildings, agreeable to the standards of corresponding standard rules of law, functioning in the territory of the Russian Federation and directed to provide public order and safety of participants and spectators, in the presence of acts of operational readiness of sports buildings for the activities, approved in the prescribed order.

IX. Insurance

Participation in the competitions is allowed only in case of presence of the insurance of life and health from accidents (original) for each athlete. Insurance fees of the athletes carry the sending organizations.

X. VISA

Participants who need a visa to stay in Russia, by July 20, 2023, send data indicating full names, gender, passport numbers (indicating the date of issue and expiry date), date of birth and passport scanners for invitations.

The costs of entry visas are carry by the participants themselves.

XI. Applications
