CHARTER

International Union of Public Associations "International Mas-Wrestling Federation"

1. GENERAL PROVISIONS

- 1.1. International Union of Public Associations "International Mas-Wrestling Federation", hereafter named as "IMWF" or "International Mas-Wrestling Federation" is a union of public associations (organizations) non-profit corporative organization created for representation and protection of general interests, achieve socially useful goals and other goal indicated in the Charter.
- 1.2. Full name of the IMWF in Russian: Международный союз общественных объединений «Международная федерация мас-рестлинга».

Brief name of the IMWF in Russian: Международная Федерация мас- рестлинга/

Brief name of the IMWF in English: International Mas-Wrestling Federation.

Brief name of the IMWF in English: IMWF.

- 1.3. The IMWF carries out its activity in the territory of the ountries, where its member organizations acts in accordance with universally recognized rules of international law, international treaties, legislation of the country and this Charter.
- 1.4. Location of permanent Governing body of the IMWF (Presidium): Moscow (Russian Federation).

2. LEGAL STATUS OF THE INTERNATIONAL MAS-WRESTLING FEDERATION

- 2.1. Legal position of the IMWF is determined by the Civil Code of the Russian Federation, Federal Law "Non-profit organizations", Federal Law "Public Associations" and other normative legal acts of the Russian Federation, this Charter and guided by universally recognized international principles, norms and standards.
- 2.2. The IMWF is considered to be established as a legal entity from the moment of its state registration as prescribed in law, has its own isolated property, liable for the assets assigned to it, may purchase and carry out property and non-property rights from its own entity, carry responsibility, suing and being sued in a Court of Law.
 - 2.3. The IMWF has its own separate accounts and (or) budget.
 - 2.4. The IMWF is established without any limitation in time frames.
- 2.5. The IMWF has right in accordance with the established procedure to open bank accounts and other credit organizations in the territory of the Russian Federation and beyond of its territory except in the cases prescribed by Federal Law.
- 2.6. The IMWF has a round seal, containing its full name in Russian and indication of its location. The IMWF has right to have stamps, letterhead with its name, as well as symbols emblems, crests, other heraldic signs, flags and anthems and its description should be contained in the Charter.
- 2.7. Symbols of the IMWF emblem representing pictogram in a form of a circle, 2 (two) sided vertically divided into red (left side) and blue (right side) colors, on the background is the graphic element made of light strips in common representing a pictographic image of view from the air (top) of Mas-Wrestling struggle.

The image consists of two symmetrical parts regarding to the central vertical strip with two light points on both sides, applied diametrically at the center of the circle, symbolizing a combined view of the board and sticks of Mas-Wrestling.

Each of the parts consist of an external half-circle in the form of an arc, facing the central line and symbolizing the sports ground, inside of it is placed a half-circle in the form of an arc of smaller diameter facing the central line, and inside of its central arc is a circle of smaller diameter.

Inner arcs with a circle of smaller diameter symbolizing athletes sitting in front of each other and holding Mas-Wrestling stick.

In a circle, around the emblem, are verbal designations, executed by capital letters of the English alphabet, left to right, along the upper arc "INTERNATIONAL MAS-WRESTLING FEDERATION" is made in blue, and "*IMWF*" made in red at the bottom of the emblem.

- 2.8. IMWF may establish branches and open representative offices on the territory of the Russian Federation in accordance with the legislation of the Russian Federation.
- 2.9. In accordance with the legislation of the Russian Federation, the IMWF may establish organizations, as well as branches and representative offices in foreign countries on the basis of generally recognized principles and norms of international law, international treaties of the Russian Federation and the legislation of these countries.

2.10. Any interference in the activities of the IMWF by state and other bodies is not allowed, except the bodies authorized by law.

3. GOALS AND ACTIVITIES OF THE INTERNATIONAL MAS-WRESTLING FEEDERATION

- 3.1. The IMWF goals are:
- Mas-Wrestling development and propaganda in all countries of the world;
- development of activeness and independence of citizens through their participation in sports activities, protection of public health, organization of physical education, sanitary and sports-mass work;
- improvement the role of physical culture and sport for the total and harmonious development of a personality, strengthening of health, formation healthy lifestyle;
 - coordination of the IMWF members activities;
- protection of rights and legitimate interests of the IMWF members, representation of their interests in relations with third parties.
- 3.2. The subject of the IMWF activity is the implementation of measures aimed at realizing the objectives of the IMWF.
 - 3.3. The IMWF activities directions are:
- Organization of cooperation with all official organizations and individuals leading the activities associated with the above objectives, in technical, administrative and financial sectors.
- Organization and friendly relations, as well as ensuring peaceful coexistence of the respective National Mas-Wrestling Federations, protection of their interests.
- Development and promotion of international Mas-Wrestling rules approved by the International Mas-Wrestling Federation.
- Regulation of the activities related to Mas-Wrestling and carried out by the affiliated National Federations and other related organizations.
- Ensuring strict compliance with Mas-Wrestling rules in conducting any of competitions held under the control of the International Mas-Wrestling Federation.
- Selection, training, development of qualification and supervision of judges and referees activities, as well as technical and administrative staff.
- Representation and protection of interests of Mas-Wrestling in the National Olympic Committees, the International Olympic Committee and other international sports organizations.
- The adoption of fair decisions in resolving disputes or differences of opinions occurring among affiliated National Federations due to the activities associated with Mas-Wrestling.
 - Opposition of discrimination on political, racial and religious grounds in any field.
- Assisting to National Mas-Wrestling Federations in order of their recognition by the National Olympic Committees and (or) the highest sports bodies of the respective countries.
- Ensuring of official recognition of the International Mas-Wrestling Federation by the International Olympic Committee (IOC).
- The respect and promotion of fundamental Olympic principles enshrined in the Olympic Charter, the Olympic Code of ethics and the World Anti-Doping Code.
- 3.4. Certain kinds of activities, listed by law, the IMWF can only be carried out on the basis of special permission (license).
 - 3.5. Foreign economic activity in these areas is carried out in the manner prescribed by law.
- 3.6. The intervention of public authorities and their officials in the activities of the IMWF, and the IMWF interference in the activities of public authorities and other officials, is not permitted, except for the cases prescribed by the Federal law.
- 3.7. The IMWF can perform income-generating activities only insofar as it serves the achievement of the Charter purposes for which it was established, and appropriate for these purposes. Income-generating activities of the IMWF is carried out in accordance with the Civil Code of the Russian Federation and other legislative acts of the Russian Federation. The IMWF can create economic partnerships, companies and other economic organizations, as well as acquire property intended for conducting of income-generating activities. Income from income-generating activities the IMWF cannot be redistributed between its members and should only be used for achievement of the IMWF Charter goals.

4. RIGHTS AND OBLIGATIONS OF THE INTERNATIONAL MAS-WRESTLING FEDERATION

- 4.1. To implement of the Charter goals the IMWF in accordance with the current legislation has the right:
 spread freely information about its activity;
 to participate in decision-making bodies of state authorities and bodies of local self-government in the manner and amount provided by the legislation of the Russian Federation;
 to hold meetings, rallies, demonstrations, marches and pickets;
 to establish mass media and carry out publishing activities;
 to represent and protect its rights, legitimate interests of its members and other citizens in the organs of state authorities, bodies of local self-government and public associations;
 - to implement full authorities provided by the laws on public associations;
 - to take initiatives on various issues of social life, submit proposals to state authorities.
 - 4.2. The IMWF has to:
 - Comply with the legislation of the Russian Federation, generally recognized principles and norms of international law regarding the sectors of its activities, as well as norms provided by its Charter;
- Publish an annual report on the use of its property or to provide availability of acquaintance with the specified report;
- Annually inform the body that made the decision on the state registration of the IMWF, on the continuation of its activities with indicating the actual location of permanent governing body, its name and data on heads of the IMWF included in the unified state register list of legal entities;
- Provide on request of the decision-making body on state registration of public associations, the decisions of governing bodies and officials of the IMWF, as well as annual and quarterly reports on its activities provided to the tax authorities;
- Admit representatives of the decision-making body on state registration of public associations, the holding by the IMWF events;
- Cooperate with, decision-making body representatives on state registration of public associations in acquiring with the IMWF activities relating with the achievement of Charter goals and the observance of the legislation of the Russian Federation;
- Inform the Federal body of state registration about the amount of money and other property received from foreign sources, indicated in paragraph 6 of article 2 of the Federal law "Non-profit organizations", the purpose of spending these funds and using other property and about their actual expenditure and use of form and in terms which are established by the authorized Federal authority.

5. THE ORDER OF ACCEPTANCE AND WITHDRAWAL OF THE INTERNATIONAL MAS-WRESTLING FEDERATION. THE RIGHTS AND OBLIGATIONS OF MEMBERS

- 5.1. Membership in the IMWF is voluntary.
- 5.2. The IMWF members can be legal entities public associations (organizations) the National Mas-Wrestling Federations, established in accordance with the requirements of the respective Charters, following the IMWF Charter objectives, recognizing and performing the IMWF Charter, participating and cooperating in the IMWF activities, including through the financing of organizing by the IMWF programs and activities.
- 5.3. The procedure of admission to the IMWF members and exceptions shall be determined by the IMWF Conference. Admission to membership of the IMWF and the exclusion from its membership is determined by the IMWF Presidium and approved by the IMWF Conference.
 - 5.4. The IMWF members have equal rights and bear equal responsibilities.
- 5.5. National Mas-Wrestling Federations established in accordance with the requirements of the legislation, entitled to apply for membership in the International Mas-Wrestling Federation if:
- application is made in writing form and signed in the prescribed form by an authorised person of the relevant National Federation;
- corresponding National Mas-Wrestling Federation has or expects an official recognition from the Olympic Committee or highest sport authority of that country (if there was no such body, is enough state registration);

- corresponding National Federation in writing form shall comply with the requirements of the Charter and the rules of the International Mas-Wrestling Federation, conduct annual National Mas-Wrestling Championships and participate in the Championships and Superiority of the world;
- National Federation undertakes to pay the contributions established in accordance with the decision of the IMWF Conference of the financial regulations of the International Mas-Wrestling Federation;
- corresponding National Federation has gained the support of the Continental Mas-Wrestling Federation;
 - Head (President) of the National Mas-Wrestling Federation is a resident of the concerned country.
- 5.6. Submitted documents are examined by the relevant body of the Continental Mas-Wrestling Federation and after approval are recommended to the IMWF Presidium, which sends it for approval to the IMWF Conference, the only body authorized on approval of candidates to the members of the IMWF.
- 5.7. In case of presence on the territory of one country of several Mas-Wrestling Federations, only one of the above-mentioned National Federations may become a member of the IMWF.
- 5.8. In case that the National Mas-Wrestling Federation wishing to become a member of the International Mas-Wrestling Federation not officially recognized by the National Olympic Committee or highest sports authority of the concerned country, the IMWF Presidium reserves the right to investigate the situation to bring this issue to the IMWF Conference.
- 5.9. Rightful members of the International Mas-Wrestling Federation shall be entitled to attend and speak at all meetings of the Conference, to run for the relevant positions and vote on all issues on the agenda, on condition of participation of the national Federation athletes in the Championship or Cup or world Championship or Continental Mas-Wrestling Championship of the current year.
- 5.10. The National Mas-Wrestling Federations Presidents represent in the International Mas-Wrestling Federation the interests of their National Federations.
- 5.11. The IMWF members shall be entitled to withdraw from the IMWF staff by giving written notice to the Presidium not less than 6 (six) months prior to the date of withdrawal from the International Mas-Wrestling Federation.
- 5.12. The IMWF members shall pay admission and annual membership and intended contributions, additional contributions of the IMWF members to its property. The amount and method of payment of the above contributions are determined by the decision of the IMWF Conference.
 - 5.13. The IMWF members have right to:
- participate in the IMWF affairs including participation in the IMWF Conference, election and to be elected to the IMWF Governing bodies, to submit proposals to the IMWF Management bodies regarding of the IMWF issues, to participate in their consideration and in taking the appropriate decisions in the procedure defined by this Charter;
- in the cases and in the manner provided by law and this Charter, to obtain information on the IMWF activities and to get acquainted with its accounting and other documentation;
- appeal the decision of IMWF bodies, entailing civil law consequences in the cases and in the manner provided by law;
- demand, on behalf of the IMWF, in accordance with paragraph 1 of article 182 of the Civil Code of the Russian Federation, compensation for loss of the IMWF, in accordance with article 53.1 of the Civil Code of the Russian Federation;
- to challenge, on behalf of the IMWF, in accordance with paragraph 1 of article 182 of the Civil Code of the Russian Federation, committed transactions on the grounds provided for by article 174 of the Civil Code of the Russian Federation or laws about corporations separate legal forms, and to require the application of consequences of their invalidity, and also application of consequences of invalidity of insignificant transactions of the IMWF:
 - on an equal basis with other members of the IMWF to provide its services free of charge;
 - use the support, protection and assistance of the IMWF;
 - participate in all events and activities by the IMWF in accordance with the Charter;
 - free to withdraw from membership of the IMWF on the basis of the application.
 - 5.14. The IMWF members have to:
- participate in formation of property of the IMWF in the required amount in the manner, method and terms provided by the Civil Code, other laws or by this Charter;
 - not to disclose confidential information about the activities of the IMWF;
- participate in corporate decision-making, the IMWF is unable to continue its activities without in accordance with the law, if their participation is necessary for making such decisions
 - not to perform actions deliberately aimed at causing harm to the IMWF;
 - not to commit actions (inaction), which significantly complicate or make impossible the

achievement of the objectives the IMWF is created for;

— to pay membership fees provided by the IMWF Charter and other property contributions;

— provide assistance to the IMWF in the implementation of its activities;

- actively promote the implementation of the IMWF programs and its objectives;
- comply with the legislation of the Russian Federation and the requirements of this Charter, implement the decisions of the IMWF Management bodies adopted within their competence;
 - perform the obligations in respect of the IMWF;
- provide necessary information for the IMWF operation with the exception of information constituting commercial secret of the IMWF member;
- not to commit acts that violate the IMWF Charter, ethics of the fellowship relations, to refrain from activities contrary to the IMWF Charter objectives.
 - 5.15. The IMWF membership is terminated in the following cases:
 - voluntary withdrawal from the IMWF;
 - in the cases specified in paragraph 5.17. of the Charter.
- 5.16. In case of termination of the IMWF membership assets contributed to the IMWF by the person to cease membership in the IMWF including admission, membership and other fees will not be refunded.
- 5.17. The IMWF member can be terminated from the IMWF by decision of the IMWF Presidium in the following cases:
- in case of violation of the provisions of the Charter regarding the payment of contributions and membership fees of the IMWF or rules of accession to the IMWF;
 - in case of omissions in Mas-Wrestling development due to the inability to organize the work;
 - in case of prosecutions purposes contrary to the IMWF Charter;
 - in case of violation of established rules and the IMWF Charter;
 - in case of refusal of implementation of the IMWF decisions;
- in case of cancellation of documents providing the recognition of the IMWF member by the Olympic Committee or the highest sports authority of the country (or in case of state registration cancellation).
- 5.18. The decision on exception from the IMWF staff is adopted by the IMWF Conference by the initiative of the IMWF Presidium, and shall be considered adopted if voted for by 2/3 of the IMWF members, presenting at the IMWF Conference, in the presence of a quorum.
- 5.19. The rights of the IMWF member shall be terminated upon the decision of exclusion by the IMWF Conference.
- 5.20. The IMWF Conference may be elected Honorary members. Honorary members may be persons who have made significant contributions to the IMWF development. The number of the IMWF honorary members is not limited.
- 5.21. The status of the IMWF Honorary member is determined by the Regulation "Honorary members of the International Mas-Wrestling Federation" approved by the IMWF Presidium.
- 5.22. Records of the IMWF members is carried out by the IMWF Presidium on the basis of Statute approved by the IMWF Presidium.

6. INFORMATION OF THE INTERNATIONAL MAS-WRESTLING FEDERATION COMPETENCE BODIES, THE PROCEDURE FOR THEIR ADOPTING OF DECISIONS, THE IMWF STRUCTURE

6.1. The highest Governing body of the IMWF is the Conference which is competent to take decisions on all the IMWF activities.

The IMWF Conference is held annually. In the year of the World Championship the meeting is held on the day preceding the date of the Mas-Wrestling World Championship beginning (among adults). The President, or in his absence the General Secretary of the International Mas-Wrestling Federation preside at the IMWF Conference.

The IMWF Conference may be convened on the President initiative, by decision of the IMWF Presidium at the written request of the IMWF Control and Audit Commission or at the written request of more than 2/3 of the total members of the IMWF.

In the IMWF Conference with voting rights can take part members of the IMWF Presidium, members of the IMWF Control and Audit Commission, the representatives of legal entities – public associations that are the

IMWF members (hereinafter - "Delegates"). Each National Mas-Wrestling Federation shall be entitled to participate in the IMWF Conference not more than 3 (three) representatives, but each National Federation has the right to only 1 (one) vote.

Before the Conference the representatives of the National Mas-Wresling Federation present their credentials to the members of the Mandate Committee, appointed by the Presidium for each Conference separately. The credentials must be properly signed and bearing the official seal of the appropriate National Mas-Wrestling Federation.

All the issues are attentively examined at the Conference included in the agenda approved by the Presidium and sent to all National Mas-Wrestling Federations and Honorary members of the International Mas-Wrestling Federation together with the invitation to participate in the Conference not later than 1 (one) month before the date of the Conference. During the Conference, at the request of 1/3 of representatives of all member of the IMWF of the National Mas-Wrestling Federation with the right to vote can be brought additional issues on the agenda.

The issues proposed by the members of the IMWF National Mas-Wrestling Federation for inclusion in the agenda of are submitted for the Presidium consideration not later than 40 (forty) days prior to the date of the Conference. Issues, which information was received by the Presidium after the above deadline will not be considered.

- 6.2. The exclusive competence of the Conference includes the following issues:
- 6.2.1. Approval of the IMWF Charter, amendment in it;
- 6.2.2. The definition of priority activities of the IMWF, principles of forming and using its property;
- 6.2.3. Determination of the order of admission to the IMWF membership and removal from it.
- 6.2.4. Election of the Presidium members for a period of 4 (four) years, the early termination of their powers, pre-election members of the Presidium in case of expansion the activities of the IMWF or in case of early termination of their powers;
- 6.2.5. Election of the Chairman and members of the Control and Audit Commission for a period of 4 (four) years, the early termination of their powers, pre-election members of the Control and Audit Commission;
- 6.2.6. Election of the IMWF President for a period of 4 (four) years, the early termination of his powers;
- 6.2.3. Election of the IMWF Vice President for a period of 4 (four) years, the early termination of his powers;
- 6.2.4. Election of the IMWF General Secretary for a period of 4 (four) years, the early termination of his powers;
 - 6.2.5. Approval of reports of the Presidium work, Control and Audit Commission of the IMWF;
 - 6.2.6. Approval of annual reports and accounting (financial) statements of the IMWF;
- 6.2.7. Decisions on the amount and payment method by the IMWF members of membership fees and additional contributions.
- 6.2.8. Decisions on the establishment of the IMWF other legal entities, participation of the IMWF in other legal entities, creation of branches and opening of representative offices of the IMWF;
- 6.2.9. Decisions on reorganization and liquidation of the IMWF, on the appointment of the liquidation Commission (liquidator) and approval of the liquidation balance.
 - 6.2.10. The appointment of an audit organization or individual auditor of the IMWF;
- 6.2.11. Decision-making on all concerned issues and proposals of the IMWF submitted by National Mas-Wrestling Federations and associated with the development of Mas-Wrestling in accordance with the Charter:
- 6.2.12. Decision-making for all claims in respect of the activities and decisions of the President, General Secretary, Presidium, and other bodies of the International Mas-Wrestling Federation;
- 6.2.13. Decision-making on all issues that are not directly attributable to the competence of other bodies of the International Mas-Wrestling Federation according to the Charter.
- 6.3. The IMWF Conference has the power to solve the issues in the case of participating delegates, representing more than half of the IMWF members.

All the delegates who present at the Conference, the Conference agenda may be amended and/or supplemented. The decisions of the Conference for amendment and/or supplementation of the agenda, and on matters included in the agenda, accepted unanimously.

6.4. All the issues indicated by paragraph 6.2 are the exclusive competence of the IMWF Conference, decisions on all these issues is taken by a qualified majority of 2/3 vote of the delegates present at the Conference.

Form of voting is determined by the Conference.

In the absence of quorum for holding of the Conference declared the new date of the Conference. The change of the Conference agenda is not allowed in this case.

Voting at the Conference is carried out by the principle "one delegate – one vote".

- 6.5. The Conference protocol shall be made within 30 (thirty) days after the closing of the Conference in 5 (five) copies. All copies are signed by the Chairman of the Conference and Secretary of the Conference.
- 6.6. The Conference provides to the IMWF members accessibility of the Conference decisions for review by posting on the official website of the IMWF.
- 6.7. A permanent collective governing body of the IMWF is the Presidium, leading the IMWF in the period between the Conferences, as well as the rights and obligations of a legal entity. The Presidium is accountable and elected by the Conference for a period of 4 (four) years among the representatives of the IMWF members in the amount determined by the Conference, but not less than 4 (four) members.

The Presidium members can only be individuals.

The persons elected as members of the Presidium may be re-elected unlimited number of times. By decision of the Conference of the powers of any member (or all members) of the Presidium can be terminated early.

Propose candidates for election to the members of the Presidium shall be entitled to:

- Presidium;
- Legal entities public associations which are members of the IMWF.

Candidates for the IMWF Presidium should be nominated by legal entities – public associations that are members of the IMWF, not later than 15 (fifteen) days prior to the date of the Conference, and the agenda should include separate issue of electing members of the Presidium by sending a written proposal, signed by an authorized person and contains the full name of the candidate and justification of nomination for election to the members of the Presidium.

The Presidium when considering and deciding on their inclusion (non-inclusion) of the candidates in the list for voting at the Conference shall be entitled to supplement such a list on their own. The decision on the inclusion (non-inclusion) of the candidate in the list for voting at the Conference shall be taken by simple majority of votes of the Presidium members attending the meeting.

- 6.8. The competence of the Presidium include deciding of the following issues:
- 6.8.1. Leading of the IMWF activity between the Conferences;
- 6.8.2. Preliminary approval of the annual report and the annual balance sheet with the subsequent adoption at the Conference;
 - 6.8.3. Approval of the financial plan of the IMWF and amendments;
- 6.8.4. The disposal of the IMWF property, including finance, implementation of the legal entity rights on behalf of the IMWF and the fulfilment of its obligations in accordance with the Charter;
 - 6.8.5. Prioritization of projects and programs of the IMWF;
 - 6.8.6. Acceptance and rumination form the IMWF members;
 - 6.8.7. Determining the amount and directions of use of funds and property of the IMWF;
- 6.8.8. Synthesis of proposals for changes and/or supplementation of the IMWF Charter with the subsequent imposition of these proposals to the Conference;
- 6.8.9. Creation of Commissions and Committees, approval of its Regulations and other Provisions in accordance with the Charter;
 - 6.8.10. Control over execution of the Conference decisions;
 - 6.8.11. Ensuring compliance with the Charter provisions, rules and regulations of the IMWF;
- 6.8.12. Development regulations and amendments (if necessary) to this Charter, Mas-Wrestling rules and Regulations of the International Mas-Wrestling Federation;
 - 6.8.13. Appointment of members of the Mandate Commission on the IMWF Conference;
- 6.8.14. Consideration and approval of applications of candidates on carrying out of official competitions of the International Mas-Wrestling Federation;
 - 6.8.15. Reception of reports and documents from the National Mas-Wrestling Federations;
- 6.8.16. Adoption of Mas-Wrestling rules and other provisions regulating the activities of the International Mas-Wrestling Federation;
 - 6.8.17. Solution of other issues not included in exclusive competence of the Conference.
- 6.9. The Presidium meeting shall be convened by the President or at the request of 1/3 of its members. The meeting of the Presidium is held by the President of the IMWF or on behalf of any of the members of the Presidium. In any circumstances the Presidium meeting to be held at least 2 (two) times a year.
 - 6.10. The Presidium is authorized to take decisions if attended by more than half of its members.

Decisions are taken by simple majority of those present at a meeting of the Presidium members in the presence of a quorum. Form of voting is determined by the Presidium. The protocol of the Presidium meeting is signed by the Chairman and Secretary leading of its record. The President shall provide of the IMWF members accessibility of resolutions of the Presidium for reviewing by posting on the official website of the IMWF.

6.11. The Presidium is composed of President, General Secretary, Vice-Presidents and elected members of the Presidium.

The Presidium consists of not more than 2 (two) representatives from each National Mas-Wrestling Federation. Taken into account beyond quotas: President, General Secretary and First Vice-President of the International Mas-Wrestling Federation.

The Presidium members and the IMWF President electing procedure at the Conference:

- first, the IMWF President election is conducted;
- then members of the IMWF Presidium:
- General Secretary, Vice-Presidents shall be elected from the members of the Presidium on the proposal of the candidates by the IMWF President.
- 6.12. The right to be elected members of the Presidium are the President of the National Mas-Wrestling Federation and other person submitting written recommendations corresponding to his / her nationality (or citizenship) of the National Mas-Wrestling Federation. The candidates to the Presidium must be the citizens (or subjects) of the country which the recommended National Mas-Wrestling Federation is established in. Applications for election to membership of the Presidium are submitted to the Presidium not later than 2 (two) months before the date of the Conference.
- 6.13. For vacancies in the Presidium arising due to the termination of certain members may be elected new members only at the IMWF Conference.
- 6.14. The IMWF President is the Chief Executive officer of the IMWF and shall be elected at the Conference by secret or open ballot (in accordance with the decision of the Conference) for a period of 4 (four) years. The President supervises the President and the activities of the IMWF in general. The President is accountable to the Conference.
 - 6.15. The candidate of the IMWF President is proposed by the National Federations.

In normal circumstances the election shall take place immediately after the report of candidates for the main directions of activity of the International Mas-Wrestling Federation.

The current President of the International Mas-Wrestling Federation may be re-elected for another term, with the exception of the duties of the President for more than 2 (two) consecutive terms.

The President is responsible for managing the IMWF activities, funds spending and hiring of administrative staff.

The President signs all documents, stipulating the types of legal and financial liability.

The President represents the interests of the International Mas-Wrestling Federation at the international level.

- 6.16. The President has right to:
- 6.16.1. Propose to the Conference candidates for the position of General Secretary, Vice-Presidents from the members of the Presidium;
 - 6.16.2. To create Committees and working groups and transfer to them part of his authorities;
 - 6.16.3. Form the Board of Trustees, and approve its Regulations;
- 6.16.4. Reimburse from the IMWF funds costs to members of the Presidium and other bodies of the IMWF incurred by them in connection with the representations of the IMWF interests, as well as costs related to the organization of missions, conducting various activities, trips and expenses of a different kind for the IMWF interests. All expenses must be substantiated;
 - 6.16.5. Realize other authorities, not inconsistent with the Charter and current Russian legislation.
- 6.17. If the post of the President becomes vacant for any reason, the duties of the President shall be performed by one of the Vice Presidents. Presidential elections shall be held at the upcoming Conference.
- 6.18. The General Secretary is the sole executive body and is elected by the Conference for a period of 4 (four) years and may be appointed for a new term.
 - 6.19. The General Secretary competencies:
- 6.19.1. To represent the IMWF in relations with international organizations, state authorities, local self-government bodies, other organizations irrespective of their organizational-legal forms without attorney;
- 6.19.2. Within his competence and the IMWF approved financial plan to manage the property and funds of the IMWF, make transactions and other legal acts that are not inconsistent with of the IMWF Charter and the legislation of the Russian Federation;
 - 6.19.3. Open bank accounts and other accounts of the IMWF;

- 6.19.4. Issue attorneys on behalf of the IMWF;
- 6.19.5. Signs official documents of the IMWF concerning financial and economic activities;
- 6.19.6. Provides compliance of the IMWF activities its Charter purposes;
- 6.19.7. Coordinates activities of the IMWF and its members;
- 6.19.8. Coordinates the activities of working groups and Committees included in the IMWF structure;
- 6.19.9. Approve the structure, schedule, conditions of remuneration of the IMWF employees, solves questions of their social security and social insurance;
- 6.19.10. Issues orders, directives, instructions and other acts obligatory for the IMWF employees execution, applies a disciplinary sanction, and encouragement, distributes duties between employees of the IMWF, define their authorities;
- 6.19.11. Make decisions about presentation on behalf of the IMWF claims and lawsuits to legal entities and citizen:
- 6.19.12. Performs within the legislation of the Russian Federation any other actions necessary to achieve the statutory goals of IMWF, except that in accordance with the Charter are within the competence of the Conference, the Presidium and the President.
- 6.19.13. The IMWF General Secretary can be a member of the Presidium, thus, may not comprise more than one quarter of the membership of the Presidium.
- 6.20. Vice-Presidents are elected by the decision of the Conference for a period of 4 (four) years may be elected for a new term. The number of Vice-Presidents is determined by the Conference.
 - 6.21. The Vice-President competences are to:
 - 6.21.1. Execute operational management of the activities entrusted to them by the President;
 - 6.21.2. Execute orders of the Presidium, the President.
 - 6.21.3. The Vice-Presidents are the members of the Presidium;

Vice-presidents act on behalf of the IMWF on the basis of issued attorney.

- 6.22. First Vice-President can be elected by the IMWF Conference.
- 6.23. The Board of Trustees. The President forms the Board of Trustees, which is formed of people with the state and public recognition. Decisions of the Board of Trustees are advisory in nature. The activities of the Board is governed by a separate Regulation approved by the President.
- 6.24. Control and Audit Commission the body realizing control over financial and economic and Charter activities of the IMWF.

The Control and Audit Commission headed by Chairman of the Control and Audit Commission is elected for 4 (four) years in the amount determined by the conference of the IMWF. The composition of the Control and Audit Commission may not include members of the Presidium and staff of the IMWF.

- 6.25. The Control and Audit Commission competence:
- 6.25.1. Oversees the financial and Charter activities of the IMWF;
- 6.25.2. Controls over the IMWF Charter observance;
- 6.25.3. Carries out control over safety of property, expenditure of funds of the IMWF;
- 6.25.4. Audits of financial and economic activities of the IMWF at least once a year;
- 6.25.5. Initiates of the exceptional IMWF Conference.
- 6.26. The next meeting of the Control and Audit Commission shall be convened by the Chairman of the Control and Audit Commission once a year. Exceptional meetings of the Control and Audit Commission may be convened on the initiative of the Chairman of the Control and Audit Commission or by decision of the Control and Audit Commission.

The meeting of the Control and Audit Commission is valid if attended by more than half of the members of the Commission.

Decisions are taken by simple majority of the members of the Control and Audit Commission in the presence of a quorum.

The meeting of the Control and Audit Commission in the Protocol signed by the Chairman of the meeting and Secretary.

- 6.27. The Chairman of the Control and Audit Commission is elected by the Conference for a period of 4 (four) years and accountable to the Conference. The Chairman of the Commission may be re-elected.
 - 6.28. The competence of the Chairman of the Control and Audit Commission:
 - 6.28.1. Directs the activities of the Commission;
 - 6.28.2. Defines the fields of activity of the Commission;
 - 6.28.3. Distributes of tasks among the members of the Commission;
 - 6.28.4. Convenes regular and exceptional meetings of the Commission;
 - 6.28.5. Organizes and conducts audit of financial and Charter activities of the IMWF;

- 6.28.6. Signs the documents of the Control and Audit Commission;
- 6.28.7. Preside at meetings of the Commission.

The Presidium and all officials and staff of the IMWF ensures the provision to the Control and Audit Commission of all the necessary materials to conduct the audit.

- 6.29. The IMWF has the right to conclude a contract with a specialized auditing company for the audit and confirm annual financial statements (external audit). The external auditor is approved by the decision of the Conference upon the recommendation of the Presidium.
- 6.30. The IMWF has the right in accordance with the law to establish branches and representative offices, acting in accordance with the Regulations approved by the Presidium. Te IMWF rights and its structural subdivisions for property management are determined by the current legislation and documents of the IWMF.

7. PROPERTY AND FINANCIAL AND ECONOMIC ACTIVITIES OF THE INTERNATIONAL MAS-WRESTLING FEDERATION

- 7.1. The IMWF in accordance with the legislation of the Russian Federation may own buildings, housing, equipment, inventory, monetary funds in roubles and foreign currency, securities and other property necessary for activities provided for in this Charter.
- 7.2. The IMWF can make in relation to the ownership of property any transactions not contradicting the legislation of the Russian Federation and this Charter.
 - 7.3. The property transferred to the IMWF is the property of the IMWF.
 - 7.4. Sources of formation of property of the IMWF in monetary and other forms are:
 - regular (annual) and non-recurring receipts from the IMWF members;
 - voluntary property and other contributions and donations;
 - revenues from sales of goods, works, services;
 - dividends (incomes, interests) received on shares, bonds, other securities and deposits;
 - the profits derived from the ownership of the IMWF;
 - other not prohibited by law, incomes.
 - 7.5. The following types of contributions in the IMWF:
 - entrance fee,
 - annual fee;
 - earmarked contribution (an additional property contribution).
- 7.6. Determination the amount and method of membership payments, decision of introduction of additional property contributions of the IMWF members in its property is determined by the Conference.
- 7.7. The term of entrance fee payment within 1 (one) month from the date of the IMWF entrance. Term of annual payment within 1 (one) month from the end of the financial year. Payment term of earmarked and other additional property contributions shall be determined by the Conference decision.
- 7.8. The IMWF member is entitled to obtain information about the IMWF activities and study its accounting and other documentation, by sending a written request to the General Secretary. The General Secretary is obliged to consider the request and respond within 1 (one) month.
- 7.9. the IMWF is the owner of its property and is liable for its obligations with all its assets. The IMWF is not liable for the obligations of its members, unless otherwise provided by law. The IMWF members are not liable for its obligations. This Charter provides for the subsidiary liability of the members of the IMWF.
- 7.10. the IMWF conducts operational, accounting and statistical records in accordance with the legislation of the Russian Federation.
 - 7.11. The financial year shall be from 1 January to 31 December inclusively.
- 7.12. The IMWF in the prescribed manner responsible for the safekeeping and management of financial and economic documents, personnel documents and other documents, provides transfer on the state storage in the Central archives of the documents having scientific and historical value.

8. ORGANIZATION AND HOLDING OF INTERNATIONAL COMPETITIONS

8.1. The National Mas-Wrestling Federation take part in competitions organized by the Federation affiliated to the International Mas-Wrestling Federation. The National Mas-Wrestling Federations and its athletes with the permission of the IMWF Presidium shall be entitled to have sports relations with organizations which are not members of the IWMF or membership in IMWF is suspended. Disciplinary measures may apply

to the National Mas-Wrestling Federations which athletes violate the provisions of this Charter.

- 8.2. All international Mas-Wrestling competitions and the Continental, World Championships and World Cups held under the rules of the International Mas-Wrestling Federation. The IMWF official competitions are held in accordance with the Regulations of organization and holding of the IMWF official competitions.
- 8.3. Only athletes with a high level of training recommended by National Mas-Wrestling Federation and citizens (or subjects) of the related state are allowed to compete in the IMWF international competitions. The IMWF Presidium is able to make decision on the admission of athlete participation in the IMWF international competitions in exceptional cases. All athletes (excluding hosting country athletes) receive invitations for competitions through their National Mas-Wrestling Federation.
- 8.4. The National Mas-Wrestling Federations are responsible for the organisation of Mas-Wrestling internal competitions.

9. INTERNAIONAL COMPETITIONS

- 9.1. All official international competitions included in the Calendar of events and approved by the IMWF Presidium.
- 9.2. If for objective reasons the competition was not included in the Calendar of events, the country-organizer informs the International Mas-Wrestling Federation in advance and 3 (three) months prior to the competition shall notify the administrative body of the IMWF concerning the date and venue.
- 9.3. The results of the competition must be submitted to the IMWF General Secretary no later than 7 (seven) days after the end of the competition, obligatory.
- 9.4. The National Federations organizing Mas-Wrestling international competitions, agree to timely fulfil their financial obligations to the International Mas-Wrestling Federation.

10. ANTI-DOPING CONTROL

- 10.1. Do not use any substance aimed to artificial increasing performance of an athlete. In this case we apply Anti-Doping provisions of the International Mas-Wrestling Federation, rules of the World Anti-Doping Agency (WADA) regulations and the World Anti-Doping Code (WADC)
- 10.2. Participants of competitions held under the auspices of the International Mas-Wrestling Federation, and officials and authorized people should not interfere with sampling for doping control.
- 10.3. The decision to apply sanctions against violated athletes, officials and federations shall be determined in accordance with Anti-Doping regulations of the International Mas-Wrestling Federation, the World Anti-Doping Code (WADC) and the rules of the World Anti-Doping Agency (WADA).

11. SPECIAL PROVISIONS. DISPUTE RESOLUTION

11.1. All disputes arising among the IMWF members, the IMWF member bodies, athletes and bodies of the IMWF, shall be referred to the Refereeing and Disciplinary Committee. In case of disagreement with the decision of the IMWF Refereeing and Disciplinary Committee, they have right to appeal to the IMWF Presidium, which may independently review the decision of the Refereeing and Disciplinary Committee, or refer the matter to the resolution of the IMWF Conference. In case of impossibility of dispute settlement within the IMWF structure, the applicant may apply to the relevant Courts including to the Court of Arbitration for Sport in Lausanne.

12. THE AMENDMENTS TO THE CHARTER OF THE INTERNATIONAL MASWRESTLING FEDERATION

- 12.1. Amendments to the Charter are accepted and approved by the Conference, by a qualified majority of 2/3 votes of the delegates of the IMWF members present at the Conference, the presence of a quorum.
- 12.2. Amendments to the Charter should have state registration in accordance with the law and acquire legal force from the moment of registration.
 - 12.3. This Charter shall become legal after the appropriate state registration.

13. THE PROCEDURE FOR REORGANIZATION AND LIQUIDATION OF THE INTERNATIONAL MAS-WRESTLING FEDERATION

- 13.1. The IMWF can be reorganized in the order determined by the Civil Code of the Russian Federation, Federal laws "Public associations", "Non-profit organizations", other Federal laws.
- 13.2. The IMWF by decision of its members can be transformed into a Public Organization, Autonomous Non-profit Organization or Fund.
- 13.3. The decision on reorganization adopted by the Conference by a qualified majority of 2/3 votes of the delegates of the IMWF members present at the Conference, in the presence of a quorum.
- 13.4. The IMWF can be liquidated on the basis and in the manner provided by the Civil Code of the Russian Federation, Federal laws "Public associations", "Non-profit organizations", other Federal laws.
- 13.5. The decision on liquidation and appointment of the liquidation commission, is adopted by the Conference by a qualified majority of 2/3 votes of the delegates of the IMWF members present at the Conference, in presence of a quorum or by the court.
- 13.6. General meeting or the Court that made the decision on liquidation shall appoint a liquidation commission (liquidator) and shall sets out the order and terms of the IMWF liquidation in accordance with acting law.
- 13.7. Since the appointment of the liquidating commission it takes authority to manage the IMWF activities. The liquidation committee on behalf of the IMWF acts in a court.
- 13.8. The liquidating commission places in press in which publish data on state registration of legal entities, publication on the IMWF liquidation, procedure and terms of requirements submitting by its creditors. The deadline for submission of requirements by creditors may not be less than 2 (two) months from the date of publication.
- 13.9. The liquidation commission takes measures to identify creditors and recover receivables and notify in writing the creditors on liquidation of the IMWF.
- 13.10. At the end of the term for presentation of requirements by creditors the liquidating commission makes intermediate liquidating balance which contains data on the IMWF property composition, list of creditors filed claims and results of their consideration. The intermediate liquidation balance sheet is approved by the Conference by a qualified majority of 2/3 votes of the IMWF delegates members attend at the Conference, in the presence of a quorum or authority that made the decision on its liquidation.
- 13.11. If the IMWF funds are insufficient to satisfy creditors 'requires, the liquidation committee sells the property of the IMWF at public auction in the manner prescribed for execution of court decisions.
- 13.12. The payment to the IMWF creditors is made by liquidation commission in order of priority established by the Civil Code of the Russian Federation, in accordance with the intermediate liquidation balance.
- 13.13. After completion of settlements with creditors the liquidation commission makes up a liquidation balance which is approved by the Conference, by a qualified majority of 2/3 votes of the delegates of the IMWF members attend at the Conference, in the presence of a quorum or authority that made the decision on liquidation.
- 13.14. The property remained after satisfaction of requirements of creditors is directed in accordance with this Charter for purposes for which the IMWF was created and directed to charity.
- 13.15. Liquidation is considered as completed, and the IMWF liquidated after making an entry in the unified state register of legal entities.

The decision on the state registration of the International Union of Public Associations "International Mas-Wrestling Federation" is made by the Ministry of justice of the Russian Federation on May 11, 2017 (No. 0012070556).

Information about state registration is brought in the Unified state registration list of legal entities on May 16, 2017 under main state registration number 1177700008034.
